



Ballough School Pandemic / Illness Response Plan

This document outlines the key actions that we will take at Ballough School while the Island is taking steps to mitigate against the C-19 virus as well as other common illnesses. Transition through the stages is based on the perceived level of risk, the Exit Framework and advice / directives from our Department, the Public Health Team and CoMin. Our actions will evolve with our understanding. The decision to move between Level 0 and Level 1 will be taken by the Headteacher, or in his absence the member of staff in charge at that time. This decision will be made based on the most up to date information available at that time. Proportionate mitigations to reduce risk levels include, face coverings / masks, maintaining "safe space", hand washing, being outside and enhanced ventilation. This is also valid should there be outbreaks such as norovirus etc.

1 - Face coverings - The school will support any child or adult who wishes to wear a face covering at any time, for any reason.

2 - Home Learning. Limited Home Learning will be made available for pupils who are not attending school, who are well, but have been issued with a self isolation notice, as a high risk contact. This will consist of a learning pack designed by the teacher to meet the child's needs. At this level it will not be possible to provide daily Teams meetings, as the staff will be working directly with the rest of the children in school. This pack will not be routinely provided for children who are off school due to illness, or children who are in isolation due to the family choosing to travel.

3 - Dinners - Class R2 first sitting @ 12 (1150 on swimming days). Those not in hall have playtime (in classrooms if weather inappropriate) supervised by 1 lunchtime assistant. Other assistant with children eating.

4 - Off site visits - This can cover a wide range of activities, some of which may well be safe to take place at level 1 e.g. a walk around the local area as part of a topic, where as a whole school trip to multi-school venue may not be suitable. For this reason a decision about off-site visits at this level will be made following consideration of the risk level and the mitigations that will be in place at that event.
